**MEMBERSHIP INFORMATION**

***Membership year begins June 1. Renewals should be submitted by May 31 each year.***

The Dearborn Figure Skating Club (D.F.S.C.), has been created to foster, sponsor, organize and promote national and international amateur sports competitions in singles, pairs, dance and synchronized team figure skating, as well as to support, develop and train amateur athletes in the various disciplines of figure skating for advancement and competition.

The DFSC invites membership applications from those individuals who wish to assist the DFSC in the fulfillment of the purposes and activities of the organization. Membership privileges, benefits, and responsibilities are set forth in the Constitution and By-Laws of the Dearborn Figure Skating Club, Inc. *If any member is under the age of 18, a parent/guardian must also become a member.* The following types of membership are offered:

**INDIVIDUAL – PRIMARY:** A member who represents DFSC in skating; The member may belong to another USFSA-sanctioned figure skating club as a secondary member. This person receives all the benefits of the organization. *If this member is under the age of 18, a parent/guardian must also become a member.* The individual receives membership in the DFSC and USFSA and receives the USFSA publication Skating Magazine, and a copy of the Constitution and By-Laws upon request. The member may purchase ice time and participate in DFSC functions, both on and off the ice. Voting privileges are granted if the DFSC member is at least 18 years of age. (A maximum of two votes per household.)

Individual-Primary annual dues: \$1000.00 (\$50.00 if only skating on the Adult Synchro Team)  
Parent annual dues: \$30.00 (required if skater is under 18 years of age)

**INDIVIDUAL – NON-SKATING ADULT:** This individual has all the privileges of an “Individual – Primary” member with the exception of on-ice participation. **Parents of skaters do not use this category.**

**Skating coaches** may also join in this category, *provided they are not engaged in competition as a representative of DFSC.* This membership does not entitle the individual to teach on club ice. Permission to teach on club ice must be approved by the Board of Directors on an individual basis.

Non-Skating Adult annual dues: \$50.00  
Additional family members in this category **do not** receive on-ice privileges.

**ADDITIONAL FAMILY MEMBERS:** Other family members residing in the same household may join in this category. This member receives the same benefits as the “individual” member with the exception that only one set of publications is sent to each household.

Additional Family Member annual dues: \$30.00.

**There are other membership applications for the following. Please use the appropriate application:**

**INDIVIDUAL – SECONDARY:** An individual with a primary membership in another USFSA club but who wishes to participate in the DFSC. *If this member is under the age of 18, a parent/guardian must also become a member.* A secondary member receives all the same benefits provided an “individual – primary” member except for membership in the USFSA through the DFSC and benefits related to such membership; nor may a secondary member vote or hold a Board of Directors position.

**JUNIOR MEMBER:** Junior Membership in Dearborn Figure Skating Club is open to individuals who are enrolled in the Basic Skills program of United States Figure Skating Association (USFSA) and who do not test or compete at levels above those of the Basic Skills program.
